When the dissolution of a corporation is on the itinerary, the first thing that is generally done is holding a meeting of the board of directors. At the meeting, the members propose a resolution to close the business. This is called a termination proposal. All stockholders who are entitled to vote must receive 10 days prior notice.

A copy of the resolution authorizing the dissolution shall be certified by a majority of the board of directors or trustees and countersigned by the secretary of the corporation. The Securities and Exchange Commission shall thereupon issue the certificate of dissolution. (62a) Section 119. Voluntary dissolution where creditors are affected.
